

MEMORANDUM OF UNDERSTANDING

BETWEEN

NEHRU GRAM BHARATI (DEEMED TO BE UNIVERSITY), PRAYAGRAJ,
UTTAR PRADESH, INDIA



AND

SURINAME HINDI PARISHAD (SHP)



This Agreement made and entered into on this **SUN**day of **JUNE 6TH** between Nehru Gram Bharati (Deemed to be University) (hereinafter called NGB(DU) situated at Kotwa-Jamunipur-Dubawal, Prayagraj 221505 (a Deemed University, established U/s 3 of UGC Act 1956) and **SURINAME HINDI PARISHAD** (hereinafter called **SHP**) with its registered office at **HINDILAN # 12, FLORA, PARAMARIBO-SURINAME**

1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

- to promote interaction between NGB(DU) and **SHP** in mutually beneficial areas.
- to provide a formal basis for initiating interaction between NGB(DU) and **SHP**

2. NON-EXCLUSIVITY

The relationship of the parties under this MoU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular research agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

3. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 3 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party.

4. RELATIONSHIP

Nothing in this MoU shall be construed to make either party a partner, an agent or legal representative of the other for any purpose.

5. ASSIGNMENT

It is understood by the Parties herein this MoU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.
