India Space Week, which is an autonomous institute with full support from the Government of India, organizes various educational programs to arouse the interest of students in space science in collaboration with the Government of India and other state governments.

India Space Week having its principal place of business at New Delhi, Union Territory of India Delhi, located at BA/14B, Janakpuri, New Delhi-110058, India (hereinafter referred to as (ISW), which expression shall, unless repugnant to the context thereof, include its successors and permitted assigns of the FIRST PART

And

Nehru Gram Bharati (Deemed To Be University), University in Uttarpradesh located at Prayagraj, Uttar Pradesh India, Post Office, Kotwa- Jamunipur, Civil Lines Prayagraj, Prayagraj, Uttarpradesh (hereinaster referred to as 'Nehru Gram Bharati (Deemed University)') of the SECOND PART (who for the purpose of this Mol are hereinafter individually referred to as 'Party and collectively referred to as the 'Parties")

- 1. WHEREAS India Space Week, a premier academic and research organization of India is engaged in the advanced research and education in the field of applications of Space, Science, Computing and Technologies has developed expertise and capabilities in above mentioned areas over the years.
- 2. WHEREAS Nehru Gram Bharati (Deemed to be University) is a Uttarpradesh University, running AICTE approved courses including PG Diploma, B.Ed, M.Ed, BCA, MBA/PGDM, D.El.Ed, B.A., M.A., MCA, UG Diploma., etc. through affiliating institutions, Bearing Registeration Number 1117/2006-2007
- 3. In light of the preceding context, our shared goal is to foster educational and scientific synergy for mutual advancement via a collaborative Space, Science, Computing, and Technology initiative spanning durations of 1-6 months, 1-2 years, and 3-4 years, encompassing Certificate, Diploma, and Degree Programs correspondingly.
- 4. Nehru Gram Bharati (Deemed to be Univeristy) will provide resources such as Infrastructure in Space Science and technology to support India Space Week's educational initiatives.

5. India Space Week and Nehru Gram Bharati (Deemed to be Univeristy) parties will collaborate on research projects in space science and technology, with a focus on advancing knowledge and innovation in these fields. Vice Chancellor

India Space Week pleased to inform Nehru Gram Bharati (Deemed to be Univeristy) that as part of our Memorandum of Understanding (MoU) with Nehru Gram University, the esteemed Dean or Vice-Chancellor, of the university will be actively involved in the India Space Joint Association of the program (Council Board). This collaboration will further enhance the program's professionalism and academic integrity, ensuring a successful and impactful experience for all participants.
- 9. India Space Week and Nehru Gram Bharati (Deemed to be Univeristy's) Students and teachers who actively participate in space, science, computing, and technology will be honored as team members of the India Space Week. They will have the opportunity to engage in research and work on exciting projects related to Space Science and Satellite Development.
- 10. Nehru Gram University hereby allocate dedicated space within its premises to India Space Week, establishing it as the official nodal body for the office" This formalizes the agreement and designates Nehru Gram University as the host and support for India Space Week.

Scope of Academic Interaction:

Both India Space Week (ISW) and Nehru Gram Bharati (Deemed To Be University) shall encourage interaction between the India Space Week team, Scientists, Engineers research fellows, research scholars, faculty members and students of both the organizations through following arrangements:

a) Sharing of faculty for limited periods as mutually agreed upon from time to time,

b) Organization of joint meetings, conferences, and seminars upto 7 days,

- c) Practical/summer online/ offline training at Nehru Gram Bharati (Deemed to be Univeristy) students by India Space Week,
- d) Joint guidance of students projects/thesis, online offline/ workshops / lab and,
- e) Joint Certificate, Diploma and Degree programme as per following mutually agreeable terms.
- f) Event Organization, India Space Week will organize space-related events and activities in collaboration with Nehru Gram University, including conferences, workshops, and exhibitions upto 15 days.

Joint Certificate, Diploma and Degree Progamme:

i. The Scientists/Engineers/ Research Scholars/ students and teams member working at India Space Week, Delhi on a regular post and having space field knowledge and research, or equivalent degree from reputed institutions/university with minimum of five years of experience would be eligible to register at Nehru Gram Bharati (Deemed to Be University) for Space, Science, Computing and Technology.

ii. India Space Week Scientists/Engineers/Students fulfilling the educational qualifications as stated above and having more than five years of research experience would be exempted from the written test/ screening test for admission to get the Degree in Space, Science, Computing and Technology programme. Such scientists /Students, instead, will be required to prepare a report and make a presentation on their proposed area of research.

iii. The India Space Week, students, Junior and Senior Research Fellows (JRFS/SRFs), Delhi will also be allowed for registering for Space, Science, Computing and Technology at Nehru Gram Bharati (Deemed To Be University) and they will have same status like CSIR-UGC Fellows for registering for Space, Science, Computing and Technology programme at Nehru Gram Bharati (Deemed To Be University). They shall also be exempted from written/screening/classes test.

iv. Such Scientists/Engineers/JRFs/SRFs, will be treated as full time Ph.D Scholars and students awarded by the degree by the Nehru Gram Bharati (Deemed To Be

University).

v. India Space Week will have to be registered under the joint supervision of a Space, Science, Computing and Technology guide from India Space Week and Nehru Gram Bharati (Deemed To Be University) and the India Space Week guide will be co-opted as Member of RDC of Nehru Gram Bharati (Deemed To Be University) for JRFs/SRFs registered under him.

vi. India Space Week will provide lab assitance/ research facilities and the work would be carried out at India Space Week, Delhi. Nehru Gram Bharati (Deemed To Be University) will recognize India Space Week, Delhi as one of its approved Research Centers.

vii. India Space Week R&D and library facilities would be provided to students/faculty registered at Nehru Gram Bharati (Deemed To Be University) as Space, Science, Computing and Technology students or teaching at Nehru Gram Bharati (Deemed To Be University).

viii. India Space Week R&D facilities would be provided to students/faculty registered at Nehru Gram Bharati (Deemed To Be University) as Space, Science, Computing and Technology students or teaching at Nehru Gram Bharati (Deemed To Be University).

SHARING OF FACILITIES

Nehru Gram Bharati (Deemed To Be University) shall make provisions to share their respective important R&D/lab facilities in order to promote academic and research interaction in the areas of cooperation.

India Space Week and Nehru Gram Bharati (Deemed To Be University) shall permit the exchange of technology developed in-house in the areas of cooperation, if permissible, within the rules governing the two institutions.

Nehru Gram Bharati (Deemed To Be University) shall provide access to the library facilities to Scientists, Engineers, Faculty members and Students as per the prevailing rules and norms in the respective institutes.

CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

India Space Week, Team/Scientist/Engineers could register limited number of students (Two for Scientist-E and Four for Scientist-F and above) for Ph.D. supervision from Nehru Gram Bharati (Deemed To Be University) provided their names are duly forwarded by the Director, India Space Week Recognition of the scientists as supervisors would be granted by the concerned RDC of Nehru Gram Bharaati (Deemed To Be University) after due evaluation on a case by case basis, taking publications in International Journals of repute and/or International/National patents as one of the main criterion.

The collaborative programme between India Space Week and Nehru Gram Bharati (Deemed To Be University) shall be coordinated by a coordination committee appointed by Director/VC of both the Institutes.

Financial arrangements for each specific collaboration will be decided on a case-bycase basis and brought on record in each case after due approval from Heads of both the Institutions.

Effective Date and Duration of MoU

- i. This Mou shall be effective from the date of its approval by competent authorities at both ends.
- ii. The duration of this MoU shall be for a period of 15 years from the effective date.
- iii. During its tenancy, the MoU may be extended or terminated by a prior notice or not less than one year by either party. However, termination of the MoU will not in any manner affect the interests of the students/faculty/scientists, who have been admitted to pursue a programme under the MoU.

iv. Any clause or article of the MoU may be modified or amended by mutual agreement of India Space Week and Nehru Gram Bharati (Deemed To Be University).

CONFIDENTIALITY

During the tenure of the MoU both India Space Week and Nehru Gram Bharati (Deemed To Be University) will maintain strict confidentiality and prevent disclosure of all the information and data exchange under the scope of this MoU for any purpose other than in accordance with this MoU.

Both India Space Week and Nehru Gram Bharati (Deemed To Be University) shall bind their respective personnel, who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.

Further both India Space Week and Nehru Gram Bharati (Deemed To Be University) shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

CONFIDENTIAL INFORMATION

Confidential Information shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared oridentified so by the disclosing party before such disclosure or during the discussions. However confidential information shall not include any data or information which:

RESOLUTION OF DISPUTES

 This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the courts at Praygraj.

The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try resolve the dispute/difference amicably between them, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be Prayagraj and Languages of arbitration shall be English.
