This Memorandum of Understanding (MOU) is made and entered into on 19th July, 2024, by and between: Nehru Gram Bharati (Deemed to be University) (hereinafter referred to as "NGBDU"), Located at Jamunipur, Kotwa, Prayagraj and Regional Employment Exchange Office (hereinafter referred to as "REEO"), Located at Prayagraj

1. Purpose:

The purpose of this MOU is to establish a collaborative relationship between NGBDU and REEO to facilitate internship and job placement opportunities for students of NGBDU.

2. Scope of Collaboration:

REEO:

- Share information on available job opportunities and internships.
- Participate in and support job fairs and recruitment events at NGBDU.
- Conduct workshops and training sessions for NGBDU students.

4. Duration:

This MOU will be effective from 19th July, 2024 and will remain in effect for a period of one year. It may be extended upon mutual agreement of both parties.
